Since 1963 the Kenosha Achievement Center (KAC) has been creating opportunities for the personal growth and success of persons with special needs. KAC does this by removing barriers, changing perceptions and building confidence.

This position is responsible for performing janitorial and grounds keeping tasks at KAC and multiple off site contracted locations.

TYPICAL RESPONSIBILITIES:

1. Clean and sanitize restrooms, office spaces, and assigned facility spaces
2. Empty trash cans and pick up litter
3. Sweep, mop, vacuum, and wash floors
4. Restock supplies such as soap, paper towels, and toilet paper
5. Clean windows, mirrors, and glass surfaces
6. Perform light maintenance tasks as assigned
7. Seasonal yard work, i.e. cutting grass, snow shoveling, weeding, leaf pick up etc.
8. Operate power and manual equipment
9. Maintain tools and supplies and report any repairs or replacements needed
10. Work with various cleaning chemicals to perform a variety of cleaning tasks
11. Work outside in all types of weather, i.e. snow, wind, rain and heat
12. Work effectively with a culturally diverse staff and the public
13. Perform all other duties as required

The duties listed above are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related, or a logical assignment to the position.

PHYSICAL DEMANDS:

The employee must lift, push, pull, and carry a minimum of 50 pounds alone, 80 pounds with help. The employee must be able to reach, twist, stoop, kneel, bend, walk up & down steps, and climb step ladder on a frequent basis.

The mental efforts required on a daily basis include those related to reading, writing, basic arithmetic, weighing and/or measuring, and managing resources.

WORK ENVIRONMENT:
